I disconnected the breath hose from the machine and there is no blockage.

FYI. DataMaster is currently 10-7. Sam, please get with the Crime Lab ASAP and get it back into service. I'm not a supervisor any longer, but I suspect the issue is with the breath hose. There is no resistance at all when providing a sample, and the machine doesn't register/recognize when breath is being blown (i.e. - it keeps beeping, instead of changing to a steady tone).

We did a mock DUI tonight as part of Cameron's training, and discovered the issue when our test subject attempted to provide a sample.

In the meantime, we'll need to plan on utilizing Airport PD or AST for DataMaster.
