Tucker- Any grant money obtained would have a 3 to 4 year cycle, so there would be time to wait for the texts to be updated to reflect the new NFPA Standards.
	 We have a spring meeting in February and Descutner can do some committee work and meeting with Tucker to get the committee up and running in preparation for reviewing the new standard when it becomes available.
