Accordingly, the Council has considered the Accusation dated February 8, 2006.

Based upon the Council's consideration of the facts recited in the referenced Accusation,

IT IS HEREBY ORDERED

- 1. That the allegations made in the Accusation against the Respondent dated on the 8th day of February 2006, are hereby adopted and the Accusation is made, by reference, a part of this Order as though set forth fully herein.
- 2. That the Respondent's correctional officer certificate in the State of Alaska is hereby revoked; and
- 3. That this Order of Revocation shall take effect in accordance with AS 44.62.520 (a).

ACCUSATION

Terry Vrabec, Administrator of the Police Standards

Council, Department of Public Safety of the State of Alaska, moves to revoke the certificate of Desmond Bartholomew, as a correctional officer

pursuant to AS 18.65.242(a) (1), AS 18.65.245(2), AS 44.62.330 et. Seq., 13 AAC 85.210(a)(3), and 13 AAC 85.270 (a)(3), and 13 AAC 85.270 (b)(3).

The Administrator Alleges as Follows:

- On or about March 21, 1995, the respondent was hired as a Correctional officer for the State of Alaska, Department of Corrections.
- On or about April 6, 1996, the respondent
 submitted an application to the Alaska Police Standards Council
 (APSC) for a Correctional officer certificate.
- 3. On or about May 3, 1996, the respondent was certified as a Correctional officer in the State of Alaska.

4. That on March 31, 2005, while on duty at the Fairbanks Correctional Center, the respondent struck a handcuffed female prisoner with his fist, breaking the prisoners nose, as witnessed by two other correctional officers. Further that the respondent reported this incident as using defensive tactics to the area of the ear of the prisoner when again the witnesses and injury sustained indicate otherwise.

- 5. During April, 2005, the Department of Corrections conducted an internal investigation in reference to allegations that the respondent engaged in excessive force and filed a false report and determined that there was substantial evidence to support the above allegations.
- 6. On or about April 5, 2005, the respondent was Placed on administrative leave from the DOC as a result of the above mentioned conduct.
- 7. Finally that on April 28, 2005, the respondent resigned from his DOC position in lieu of being terminated for the above listed actions. The conditions of that action are set in a letter of dispute resolution that was agreed on between the State of Alaska and the Alaska Correctional Officers Association.

COUNT I

Paragraphs 1 through 7 are incorporated by reference as though set forth in detail. In addition, the administrator alleges that respondent resigned for cause relating to dishonesty or

 misconduct from employment as a correctional officer in Alaska, and therefore, his correctional officer certificate should be revoked under AS 18.65.242 (a)(2) and 13 AAC 85.270 (b)(3), which are grounds for a mandatory revocation.

COUNT II

Paragraphs 1 through 7 are incorporated by reference as though set forth in detail. In addition, the administrator alleges that the conduct described in paragraphs 4-7 demonstrates that the respondent lacks good moral character. The respondent therefore does not meet the minimum standards for a certified correctional officer established under AS 18.65.242 (a)(2) and 13 AAC 85.270 (a)(3), which are grounds for a discretionary revocation.

WHEREFORE, the administrator prays that Desmond

Bartholomew's certificate as a correctional officer in the State

of Alaska be revoked.
