**Grimes** – We will adopt the whole standard and use the chapters we find suitable.

**Green** – Will that hold us up since there are others that are so many?

**Grimes** – No, there is still a separate process to build out the program.

### NFPA 1041: Fire & Emergency Services Instructor – Dan Grimes

Grimes – FESI 1 current, 2 & 3 work was done, test bank done, FESI II is the beta for the new skill sheets. (Quick history), we certify folks at the state level providing the framework. However, to add credibility and user ability IFSAC and ProBoard, each covering different and possibly overlap. The require a change to the format of the skill sheets. We have asked is it required or wanted?

**T. Russell** – Is there a time requirement for when this would be available?

Grimes – It is very close; however, the correlation sheet needs to be lined up with the skill sheets. I too was waiting to get this Tech Committee Workgroup this summer, but it didn't happen. We did it once Feb 2022 and it was great, got a lot of work done. Was supposed to be done every six months and none of them happened.

#### NFPA 1041: Live Fire Technician - Jason Buist

**Grimes** – Live Fire Instructor has been moved under the instructor standard, updates have been provided to the admin however, no feedback. If you have it, then it is expired. There is a hold on this.

**Shield** – Clarification requested for renewals that happened.

**Grimes** – Yes, no renewals should have been done. We will have the AFSC Clerk review renewal certs for live fire in IMPACT.

### NFPA 1407: AK Rapid Intervention Technician – Dan Grimes

**Grimes** – I am the new lead, review has been done, needs to see correlation from IFSAC. Minimal changes needed. Looking for members to join as it has been a challenge finding people.

Sidebar: Grimes – We would really like TC members SME's as without them none of this can happen. Please help recruit people if we do not have volunteers it doesn't happen. The more people there are the easier it is to complete the work.

### NFPA 1521: Fire Department Safety Officer – Jake Bender

**Grimes** – Not sure if he stepped down.

**Bones** – I will take over the lead.

### **AK Rural Fire Protection Specialist – Hans Nelson**

**Nelson** – (Introduction of his position.) There is a need for RFP committee members. (Gave committee members names.) The standard is needed and was originally created this standard. We have been looking at NFPA standards that all apply in part. How many of you have seen this standard? (4 people responded.) Over 200 communities need this, and many do not understand what their needs are. (Overview of why and what is needed from this standard.) We went up to NSBFD and even with all their resources they can't get up to FFI certification. They can't meet it, so they are also in need of this Rural Standard. We need good direction and clear vision from the council. (Previous Admin quoted regarding the needs.)

**Misewicz** – We need the standard to bridge the gap between FFI and Rural to get what we need. What does AFSC want and expect so they can move forward to work with the committee?

**Nelson** – We can speak more during the agenda item for this.

Grimes - We can speak more right now.

Nelson - Yes

**Misewicz** – We are trying to bridge the gap and correlate it to the material being taught. We need to have a few changes to make it work. We need to present a product for approval to the council. I see that there is an item in Old Business.

Grimes – It is there but we can provide an answer now. The council has met on this many times, we have clarity, and they did the work. It was decent and nearly complete; however, it was part way there. Admin at the time said it was complete enough and would take it from there. It is critical and needed and people outside rural communities do not understand this. There is no one size fits all, so it needs to be flexible. The old one only referenced the 1992 standard, and the last Training Specialist kept it that way. NFPA 1001 was not the best fit and the new one referenced many parts of various NFPA standards. AFSC wanted to have our first Alaska only standard not attached to NFPA. Vision from council was to create an AK standard, take this very strong capable program and reference them to the source documents. What started this was an update to 1001 but not to the Rural standard. If it is changing, then we need to know where it is coming from. Build the program and reference the material so it can be updated and repeated. If we are teaching people to use a pump and drop it in a pond, then use the forestry document to reference that. That way when forestry updates we can update. Build it and reference what you are

doing now and connect it to a source document. It will look bad if we revise everything else but not that one.

**McMichael** – What we did with this is to have Ernie and Hans to do this program and see what worked well and what didn't. Our office is going to do assessments with communities first then send someone out there to do training. Mark was working with southeast native corporation to have curriculum created.

**Nelson** – The reference material does have NFPA standards referenced. You can see that in the standard. I think that you all need a package that you can go through.

**Grimes** – Yes, it hasn't been published. We saw the 9/10 product but not 100%.

**McMichael** – Quick comment, you will get emails from the Fire Training Specialist as we need to confirm your participation.



Bones - What is the retention policy? Are we using the scantron?

**Grimes** - Are we using scantron machine.

**Parker** - I am grading them by hand, which is why we are not getting the answer to which questions are being missed most. We are working on a way to get that too.

**Grimes** - Is it because the system is too old or test banks.

**Shield** – The Scantron company is no longer doing support and we don't have training to update LXR, scantron broke and won't read any longer. But not due to test banks I am currently working on getting tests into NetExam. Staffing was the issue. Now being pushed do to audit. Once it is up, it won't be able to be used by everyone in the state, we will still be using scantrons.

**Grimes** - Should we investigate something in between.

**Shield** - Would you like me to put my time into Net Exam or looking into a new system?

**Grimes** - You answered the question with a question. I think you answered it. Your time will be better served getting NetExam up.

**Grimes** - Thank you for getting the tests out so quickly.

**Shield** - Anecdotal was due to the request for documentation on the process.

**Shield** – I didn't remove them to show completion, they will be removed once they are reported to the council as complete.

**Knowlton** – What is IFSAC and ProBoard exactly?

**Grimes** – (Summary of what they are.)

**Mathis** – ProBoard is USA and IFSAC is international. If IFSAC issues seals, then reciprocity to ProBoard and vice versa. It is very similar to us but allows us to issue the certs.

**Sprehe** – The action item list says to get 2 new council positions and place on the agenda. What has happened with that?

**Grimes** – I think that it has been modified once before, but Boards and Commissions needs to be asked. I will contact them to find out what needs to be done.

### 8. Public Comment Period

**Grimes** – Anyone with public comment?

**Nelson** – I am new to the council meetings; I have met some of you through conference. It is cool to see you all throughout the state. I really appreciate the time and attention you all have given me in this learning process. The higher-level training and getting up to speed and I appreciate your time.

**T. Russell** – You must be at the level or above to be a CO. Also, I have not been getting all the emails and for over a year I have tried to get it resolved.

**Grimes** – Desired to be at the level, we have made exceptions, and it is in the CPM. We strive to have the level.

**Shield** – The number of CO's is misleading since many of them are inactive, and Mark and I have been working on this. We have sent out emails to verify this information. All CO's that have not done an assignment in over a year will need to reach out and do a refresher.

**T. Russell** – How many CO exceptions are made, why are so many exceptions being made. **Shield** – I would have to look back at all tests, but it is not common.

Misewicz - What is the status of the proposed training for CO? This is reference to Marks

email request for interest back in July 2023.

T. Russell – What is the status of the CO training status that Mark purposed?

**Grimes** – Nothing at this moment, as a council, we purposed that we pay someone to get CO training steps out of the way, it is a 3-step process, the step A and B was being done on your own, unless it was being done in your town. We would like to do a pay training process. AFSC ADMIN said in Spring Meeting that they would like to do this and AFSC Council approved. We have heard nothing from Admin on this process. We need to get an update.

**Nakano** – We will put out another email.

**Grimes** – Can we get a list?

Nakano - Yes

**Simonds** – I am getting emails that I was not getting before.

**Parker** – I am sending a back door email.

Simonds – I am not a certifying officer.

**Parker** - That is my mistake I will correct.

**T. Russell** – I am not getting emails through IMPACT.

**Grimes** – So this is being done a back doorway.

**Parker** – Yes, in conjunction with the normal way. To make sure it gets out.

**T. Russell** – Please update to my personal email.

Parker – Ok

**Virginia** – I am not getting them either.

**Grimes** – Can reach out to you Parker?

Parker - Yes

**Edsell** – I have had a lot of people in my area ask why we have a renewal for Instructor. Is there a way to make it easier or drop it or make it applicable only to some of the levels?

**Grimes** – There are not requirements, but states or departments may require it. We need to look at our guiding documents to be sure that the requirements are met.

**Knowlton** – If there is no current instructor in their community how can they meet the renewal requirement?

**Grimes** – Explored many options to meet requirement.

**Shield** – Contact our office to resolve this.

**Misewicz** – Going back to the question on status of "Certifying Officer Training", to confirm potential Certifying Officers (those who submitted interested letters/applications) will be receiving an email updating them on status of this training?

### e. Legislative initiatives

**Grimes** – We are understaffed for the AFSC office, in 2017 we had two full positions, an administrator and an assistant. We recognized that we needed another position and started to work on language to get that. In 2017 the admin position was combined with the Training Administrator. So, we now we have 50% of an administrator. Since then, we have been lobbying to get back the full Administrator position and add a third position. We have been lobbying ever since. We got traction this last year and they know who we are but we ran into issues when the Governor removed it. The SFM submitted one position that did not get to the top.

**Nakano** – When we submit it is confidential, when it left DPS it got cut but we do not know where the cut comes from.

Grimes – By the time we started to lobby it had already been cut. It is important to reach out to your legislators now, tell them what we need. Let them know that DPS is not asking for two positions maybe due to the political climate. We need them to know that we still believe that two positions are needed. Then when we meet with them in Juneau in February, they will already know what it is. We have unwavering support from the AFCA, the council, and the fire service. We understand that the FM office can only ask for one position. We will continue to ask for this. Last year we got the positions into the budget that were then vetoed by the governor. We met with a lot of legislators and gave them paperwork. I will get that letter out to all of you. I invite you all to come down to Juneau to help to continue to fight for this. We need each council member to get involved with their constituency to pass this on to your legislators. It was my local legislator that got this in because we were communicating on a regular basis.

**Knowlton** – We talked to our legislators, but it got vetoed by the Governors level. How do we reemphasize that these are not extra at that level?

**Grimes** – Barlow is the deputy commissioner, please stop and talk with him and explain the importance of supporting two positions for the council. My proposal is that we draft a letter to the Deputy Comm and Commissioner of DPS explaining our staffing needs. What position was asked for in the last budget?

**Nakano** – It was a range 21 – Fire Training Administrator. We are unable to share what position we are asking for this fiscal year as it is confidential.

**Grimes** – I have given this to all the legislators and gave a letter to the governor also. The

point is that we have got to keep this in front of those that make the state budget, and we serve on the governor's council, so we are doing his work, and we need to keep him informed.
